- Article 18: Prohibits the state from conferring hereditary titles, thus dismantling feudal and caste-based hierarchies.

2.2 Reservation Policy (Articles 15(4) and 16(4))

The reservation system was incorporated as a means of affirmative action, ensuring fair representation and opportunities for historically marginalized communities.

- Article 15(4): Empowers the state to make special provisions for the advancement of Scheduled Castes (SCs), Scheduled Tribes (STs), and Other Backward Classes (OBCs), especially in education.
- Article 16(4): Allows the state to provide reservation in public employment for SCs, STs, and OBCs to address structural discrimination and provide equitable access to jobs.

This affirmative action policy has played a crucial role in uplifting marginalized communities, increasing their participation in government jobs, higher education, and decision-making roles. However, the policy remains a topic of debate regarding efficacy, implementation, and the need for reforms.

2.3 Directive Principles of State Policy (DPSP)

- Promotion of Education and Health: Article 45 mandates free and compulsory education for children, while Article 47 directs the state to improve public health and nutrition.

However, effective implementation, policy reforms, and public awareness remain key to fully realizing Ambedkar's vision of a just and equitable society.
