The YMA rules reflect the ethos of the Zawlbuk, emphasizing community service, moral conduct, and the preservation of Mizo traditions. For instance:

- 1.Community Service: Just as the Zawlbuk required young men to contribute to village welfare, the YMA organizes community development activities, disaster relief, and social reforms.
- 2.Discipline and Moral Conduct: The YMA enforces strict codes of behavior, mirroring the Zawlbuk's emphasis on discipline and ethical living.
- 3. Cultural Preservation: The YMA actively promotes Mizo customs, language, and traditions, ensuring their continuity in modern society.
